# **USE CASE EXHIBIT**

### Use Case Name: Social Determinants of Health (SDOH)

**1. Purpose**. The purpose of this UCE is to set forth the requirements for PO to use HIN to send and/or receive Social Determinants of Health (SDOH) electronically. This UCE allows sending and receiving of Social Determinants of Health (SDOH) data by authorized TDSOs.

### **2.** [RESERVED]

**3. Definitions**. Capitalized terms used herein and not otherwise defined, shall have the meaning given them in the Master Use Case Agreement and the Data Sharing Agreement.

3.1. <u>Message Content</u> means all data as defined in the UCIG containing Social Determinants of Health (SDOH).

3.2. <u>Social Determinants of Health (SDOH)</u> means all conditions in the environments in which people are born, live, learn, work, play, worship, and age that affect a wide range of health, functioning, and quality-of-life outcomes and risks. This includes information that is collected in or informed by the results of Social Determinants of Health (SDOH) data.

3.3. <u>**Transactional Bases**</u> means the transmission of Message Content or a Notice within a period of time set forth in the UCIG.

#### 4. Use Case Details.

### 4.1. Primary Use

**4.1.1.** PO and HIN may send, receive, find and use Message Content for the purposes set forth in this Exhibit.

### 4.2. Additional Permissible Use

**4.2.1.** If permitted by Applicable Laws and Standards, PO may deliver data extracted from Message Content to third party vendors for further data analysis.

**4.2.2.** HIN may use Message Content for any other Use Cases that require use of the Message Content.

Additional permissible use, if mutually agreed in writing by the Parties, may be specified during the term of the Exhibit.

The Parties may make additional use of Message Content as permitted under the MUCA.

4.3. <u>Limitations on use</u> No additional limitations.

4.4. <u>Related Use Case Requirements</u> Organizations contributing data for this use case are required to onboard to the following use cases: Active Care Relationship Service, Health Provider Directory and Common Key Service.

- 5. Service Interruptions. No service interruption variations.
- 6. **Responsibilities of the Parties**. No additional responsibilities.
  - 6.1 **<u>PO Responsibilities</u>** (if PO is sending Message Content)

6.1.1 PO shall send all Message Content and Notices on a Transactional Basis.

6.2 **<u>PO Responsibilities</u>** (if PO is receiving Message Content)

6.2.1 PO shall receive all Message Content and Notices on a Transactional Basis.

## 6.3 HIN Responsibilities

6.3.1 HIN shall send all Message Content and Notices on a Transactional Basis.
