## IMMUNIZATIONS & MCIR

The Michigan Health Information Network (MiHIN) works with the Michigan Care Improvement Registry (MCIR) to improve the exchange of immunization data between healthcare providers in Michigan. MiHIN provides secure data exchange capabilities to MCIR, allowing authorized providers to access immunization records in real-time. This improves care coordination and ensures patients receive the appropriate immunizations at the right time.

## ADT NOTIFICATION SYSTEM

The ADT Notification System automates the process of notifying healthcare providers when a patient is admitted, discharged, or transferred from a hospital, improving care coordination and reducing healthcare costs. It collects data from various sources and sends real-time notifications to providers, resulting in improved patient care and reduced readmissions.

## REFERRALSPLUS

ReferralsPlus is a system that automates and streamlines the process of referring patients to specialists and other healthcare providers, improving care coordination and reducing healthcare costs. It provides a centralized platform for managing referrals and real-time access to patient data and referral information.

## MIGATEWAY

MiGateway is a secure messaging platform for healthcare providers that allows for the secure exchange of sensitive patient information, improving care coordination and reducing costs. It streamlines communication among healthcare providers and enhances patient outcomes.
