



Format Errors: Files with an incorrect format will fail to process and users will receive an unable to process message to the email associated with their sftp user.

Format errors can occur for three reasons:

- 1.) The sdoth file not being submitted as a csv.
- 2.) Incorrect quoting within the file
- 3.) Column headers being misspelled our out of order

Screening Errors: Specific rows within a file may fail to load for the following reason:

- 1.) Missing Required Field, Rows missing a required field such as First_Name or DOB will fail to load.
- 2.) Inconsistent Values, Rows with inconsistent value will fail to load. Patient and Practice/Provider information must be consistent across a single unique Screen_Id. Ex. The red highlighted rows show inconsistent values within the the column Screening_Organization_OID. The Screening_Organization_OID uses different OIDs despite both rows belonging to the same Screen_Id, "abcde." Columns highlighted in yellow are fields that must remain consistent across a single Screening_Id.
